# **Directions To Never Go Back Ranch**

#### If using your GPS: Some GPS's bring you off Sparta pike to Beech Log. That is very winding back way, and it's easy to get lost. It's easier to enter the coordinates for the corner of Beech Log Rd and Cainsville Rd: N 36 degrees 05.448' W 086 degrees 14.191'.

From Franklin / 840: Take exit 65 (TN 452E). Turn right. Travel 4.4 miles to Highway 231N (TN 452E ends at the stop sign). Turn left. Travel 5.8 miles to TN 265E (Chicken Road). Turn right. Travel 5.4 miles to TN 266S (Cainesville Pike). Turn right. Travel 1.4 miles to Beech Log Road. Turn left. Travel 2.5 miles to show site on the left, 3337 Beech Log Road.

From Murfreesboro:

Take Highway 96 Lacassas Pike (East) to TN 266S (Cainesville Pike). Turn left.

Travel 12 miles to Beech Log Road. Turn right. (If you come to Rt 265, you have gone too far.)

Travel 2.5 miles to show site on the left, 3337 Beech Log Road.

# Welcome to Never Go Back Ranch!

Unlike many agility venues, Never Go Back is a working farm as well as Kellie and Tim's home. We're glad you're here, but we ask you to please observe the following rules while you're with us.

- 1. Please DRIVE SLOWLY, 5 mph or less, at all times while you are on the property! There are chickens, geese, and ducks who roam the property freely.
- 2. Please do not arrive before 7:15. This will give time for the farm chores to be completed before you arrive.
- 3. Please park as directed. We have a lot of people to fit in and very limited parking. If you park without direction, you will most likely be asked to move.
- 4. Please obey posted "No Dogs" signs. This will include pastures where livestock are kept as well as the area near the house.
- 5. Please leave all the farm animals alone sheep, cows, bunnies, and fowl. They are easily spooked and can hurt themselves if harassed. Livestock are expensive to replace.
- 6. All exhibitors except the trial committee will need to crate out of your car. Please don't block gates or doors. If you're unsure where to park, ask Kellie.
- 7. Please pick up after your dog! Always.
- 8. Dogs must be on lead at all times when not in the ring or using the practice jump. This is an AKC rule and will be strictly enforced.
- 9. There is no spectator seating in the arena. If your dog is not running in the next 3 dogs, please do not enter the arena. If you want to watch runs, please do so from the hallway, but you must wear a mask and you must maintain 6 feet from other exhibitors to practice social distancing! You can also watch from under tents at the windows in front. A duplicate version of the gate check in sheet will be outside to help limit the number of people in the arena.
- 10. Have fun!

- Ring will run in the order listed below. Jump height order will be high to low.
- Preferred classes will be run in conjunction with regular classes at the end of the jump heights.
- Walk throughs for the larger classes will follow the AKC recommendations for COVID safety procedures.

COVID releases are required from every exhibitor. Please check your confirmation letter carefully. It will indicate if you have submitted a COVID waiver or not. You will not be allowed inside the building until you have a signed COVID waiver on file. A copy of the waiver is attached for your reference. Please adhere to all rules, especially the wearing of masks that fit over the nose and mouth. Face shields may NOT be worn in lieu of a fitted mask.

Please note that there are no restaurants or fast food chains anywhere near Never Go Back Ranch. Concessions will NOT be available on site and there are no restaurants nearby. Please come prepared with your own lunch and drinks.

# MOTC Agility Trial 10/14/20 COVID-19 Rules

An inherent risk of exposure to COVID-19 exists in any public place where people are present. COVID-19 is an extremely contagious disease that can lead to severe illness and even death. According to the Centers of Disease Control and Prevention, senior citizens and those with pre-existing conditions are exceptionally vulnerable. By entering this trial, you voluntarily assume all risks related to COVID-19 exposure.

Due to the COVID-19 pandemic, the following rules will be in place during our trial. These rules will be in effect from the Tuesday setup and continue through the end of the trial. While we are doing the best we can to make this event as safe as possible, there may still be risk of infection/exposure that we don't know about or cannot control. If you are concerned about the possibility of exposure to the coronavirus OR if you are unwilling to follow the stated rules, then please do not enter our trial.

Additional rules and regulations are based on recommendations from both the CDC and the AKC.

**Masks** – Masks will be required to be worn over the nose and mouth at all times while in the building, and while outside within 25 feet of the arena. Please bring at least one mask with you for your personal use. Masks will also be required while you are in the ring running your dog. Our judge will also be wearing a mask while in the ring. Please apply 6ft social distancing at all times.

**Illness** – IF YOU ARE ILL, DO PLEASE NOT COME! If you have been exposed to someone who has tested positive for COVID-19 in the last 14 days or if you yourself have tested positive in the last 14 days – PLEASE DO NOT COME! Exhibitors – We are limiting this trial to exhibitors only. The general public will not be allowed to watch, in an effort to limit the total number of people onsite. Should you or an immediate family member be diagnosed with COVID-19 after the closing date of our trial, your entry payment will be reimbursed.

**Ringside** - Our goal is to ONLY have the next dog on line and 3 more teams with 6ft spacing ringside. Please wait in the hallway or outside until you are called.

**Personal Hygiene** - Please wash your hands frequently. If possible bring a small bottle of hand sanitizer with you. We will endeavor to have larger bottles available for competitors to refill their own bottles if necessary. Hand sanitizer will be at each of the Scribe/Timer tables and also at the ribbon table.

**Concessions** – Concessions will not be available at this trial. Please bring your own food and drink as there are no restaurants close by.

**Leashes** - If possible, please think about using a lightweight leash that you can either put in your pocket or tie around your body.

**Walkthrough**s – We will be limiting the size of walkthroughs if necessary. The final confirmation letter will have an approximate time range, but this may change. Please pay attention to any changes that are announced.

**Ribbons** - Stickers and a variety of ribbons will also be available on a "self-serve" basis, but there will be "Xs" on the floor to indicate 6ft spacing. Again, PLEASE be respectful of social distancing.

Trial Secretary - Please again respect social distancing. A 6ft mark will be placed on the floor.

**MACH/PACH parties** – Unfortunately, for everyone's safety, there will be no MACH/PACH or other celebratory events at this trial. There will not be a central communal table or pens available for MACH/PACH bars to be signed.

**Doors** – We will mark doors as "In" or "Out" wherever possible. This is to reduce cross-traffic. Please follow the instructions on these signs.

**Changes to rules** – We may make changes to these rules prior to the start of the trial. BE SURE to read your confirmation letter to see what changes have been made. By entering the trial and signing the COVID waiver, you are agreeing to abide by all rules. Failure to follow the rules will be dealt with according to AKC regulations, up to and including requiring you to leave the trial site and bench committee hearings.

With all these additional requirements, we still hope that you and your dog will have fun getting back to running agility. Stepping into the ring, it will just be you and your dog and enjoying the thrill our sport offers us. Obviously it is not as it used to be, but hopefully, with all of us taking individual responsibility for our own actions we will have a safe and enjoyable trial.

# Murfreesboro Obedience Training Club Trial 10/14/20 COVID-19 Liability Waiver

The novel coronavirus which causes COVID-19 has been declared a worldwide pandemic by the World Health Organization.
