

# **Tennessee Valley Kennel Club Agility Trials**

**January 30 - February 1, 2026**

We are looking forward to seeing you at the upcoming TVKC trial and watching you and your dogs have a lot of fun! A few things we'd like you to know about:

## **B-MATCH FRIDAY**

On Friday after the trial, we are having a B-match for all dogs 15 months and older. Two courses will be set up. Standard on one side and jumpers on the other. One run is \$10. The second run is \$5. Cash or check is accepted.

Each run is 75 seconds to do whatever you like out there. You can use a toy. Please sign up during the trial so we can have a run order established. We will need some help with bar setting and leash running. B-Match will start no sooner than 30 minutes from conclusion of trial but may take longer to set up the course.

## **ACT SATURDAY**

On Saturday after the trial, we are hosting an ACT trial. ACT (Agility Course Test) is a great time to let your baby dog explore the trial setting! It is open to dogs 15 months and older who have not titled in AKC agility. You can select any jump height. Please bring cash or check for your entry. Cost is \$15 per run.

We are doing one each of the four ACT classes.

Jumpers 1: Jumps and tunnels. No weaves.

Jumpers 2: Jumps, tunnels and 6 weaves.

ACT 1: A-frame, table, jumps and tunnels. No weaves.

ACT 2: A-frame, teeter, table, jumps, tunnels and six weaves.

Ribbons for first four places and qualifying scores will be awarded. Titles available after two qualifying scores.

### Directions to Trial Site

#### **East Tennessee Agricultural Exposition Center, 276 Patton Lane, Harriman, TN 37748**

**From Knoxville:** Take I-40 West towards Nashville. Go about 35 miles and take the US-27 exit (Exit #347). Turn LEFT onto US-27 and go 2.3 miles. Follow "From US-27" below.

**From Nashville:** Take I-40 East towards Knoxville. Go about 130 miles and take the US-27 exit (Exit #347). Keep LEFT at the fork in the exit ramp. Turn LEFT onto US-27 and go 2.1 miles. Follow "From US-27" below.

**From Chattanooga:** Take I-75 North towards Knoxville. Go about 85 miles and take the I-40 West exit (LEFT fork). Go about 20 miles and take the US-27 exit (Exit #347). Turn LEFT onto US-27 and go 2.3 miles. Follow "From US-27" below.

**From US-27:** Turn LEFT onto 382 towards RSCC. Go 1.0 mile, passing RSCC on the right, and RIGHT towards the Expo.

- No check in is required. There will be an AKC Volunteer Measuring Judge on site to measure for height cards for those needing a measurement.

- Move-ups must be provided to the Trial Secretary in writing (fax, email or US Mail) by 6:00 pm on Monday before the trial. Move ups resulting from this trial will be accepted from day to day.
- The arena will be available from **2:00 pm until 8:00 pm on Thursday**. **Vendor spaces will be marked off. Anyone setting up crates in vendor areas will be asked to move.** All personal belongings must be removed from the building within an hour after the close of the trial on Sunday.
- This is a no-smoking building. No alcohol allowed on the show grounds.

**Anyone available to help set up on Thursday afternoon starting at 4 pm will receive a \$10 worker voucher for their next entry.**

- Friday & Sunday: Dogs will be run low to high. Saturday: Dogs will be run high to low.
- Walk throughs for the Excellent / Master classes will be grouped with the 4-16 walking and running together, and the 20-24 walking and running together.
- Class order will be as listed below for each ring. All FAST classes will walk together and then run by jump height. Briefings will be approximately 15 minutes before the class starts.
- Please see the attached timeline for estimated start times. The start time for the JWW ring on Saturday and Sunday is 9 am, but to make the schedule work with fewer down times, the JWW ring will start at 8:30 on Friday, and the Master/Exc JWW class will start with the 20 and 24 inch dogs.
- We anticipate possible down time in one ring or the other with the Exc/Master classes. The schedule has been set as best as possible with minimal down time in mind, but with the jump height numbers, this was the best schedule we could come up with. We appreciate your patience, and please know that everyone will get their walk throughs.



In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents, event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge or ACT Evaluator, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. Dogs may be entered in any jump height. There is no Regular or Preferred distinction at AKC's ACT events.

In order to acquire the ACT1 or ACT2 title certificate and have the title<sup>SM</sup> added to a dog's record, the dog must be registered/listed with the American Kennel Club. **AKC Canine Partners**<sup>SM</sup> applications may be accepted at the event and submitted to AKC with the event's results.

Dogs that are not AKC registered/listed may be registered at a later date and receive their ACT title at that time.

Dogs listed in the **AKC Canine Partners**<sup>SM</sup> program should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

**Junior Handlers** should enter their Junior Handler Number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
